Exhibit space is available in the following allotments:

1. **8 x 10 ft. booth = \$200.00(sold out)**
2. 10 x 10 ft. booth = \$250.00
3. 10 x 20 ft. booth = \$500.00
4. 10 x 30 ft. booth = \$750.00
5. 10 x 40 ft. booth = \$1000.00

Exhibitor Passes

Please register at the show's office in the south entrance lobby, prior to moving in, for your lanyard that allows all day access to the rodeos.

(Each exhibitor will receive two lanyards per 10ft. of frontage).

Security

Security will be provided after show hours. However, it is suggested that exhibitors use their own discretion in packing away valuables.

Display Services

Each booth includes grey and black drapes. 3x8ft. tables can be rented at a price of \$20.00 (plus GST) each, for the duration of the show. *(We do not provide tablecloths).*

Electricity will be provided at no charge (one 15amp dedicated circuit per booth) if required. Exhibitors are responsible for their own electrical requirements *including extension cords.*

Displays

Displays must be ready by 11:00am, October 17th and may not be removed before 7:00pm, October 19th.

Move in hours:

October 16th: 7:30am-9:00pm

Move out hours:

October 19th: 7:30pm-12:00am. Exhibitors may move out October 20th in the morning with prior approval.

Show times:

October 17th: 12:00 - 7:30pm

October 18th: 10:00 - 7:30pm

October 19th: 10:00 - 7:30pm

Racks & Display Shelves

All racks and display shelves must not exceed 8ft. in height and 3ft. on the sides. The exhibitor is required to exercise care so that the displays do not unduly obstruct visibility of adjacent booths, as per the good neighbor policy.

Display Space

Due to the high demand for display space, **please fill out your application form and send it back to us as soon as possible. Applications will be reviewed. Approval of applications will be completed by September 27, 2019.**

The committee will be solely responsible for assigning booth space to exhibitors.

Deposits

Upon approval a 50% deposit is required by September 13, 2019 for space assignment and guarantee. Final payment is due by October 11, 2019.

**** Exhibitors will not receive a refund of deposit if the exhibitor cancels after October 11, 2019. ****

Right of Refusal

The CCA Finals Rodeo Committee reserves the right to refuse rental space to anyone. It should be noted that all products for sale must be CSA approved.

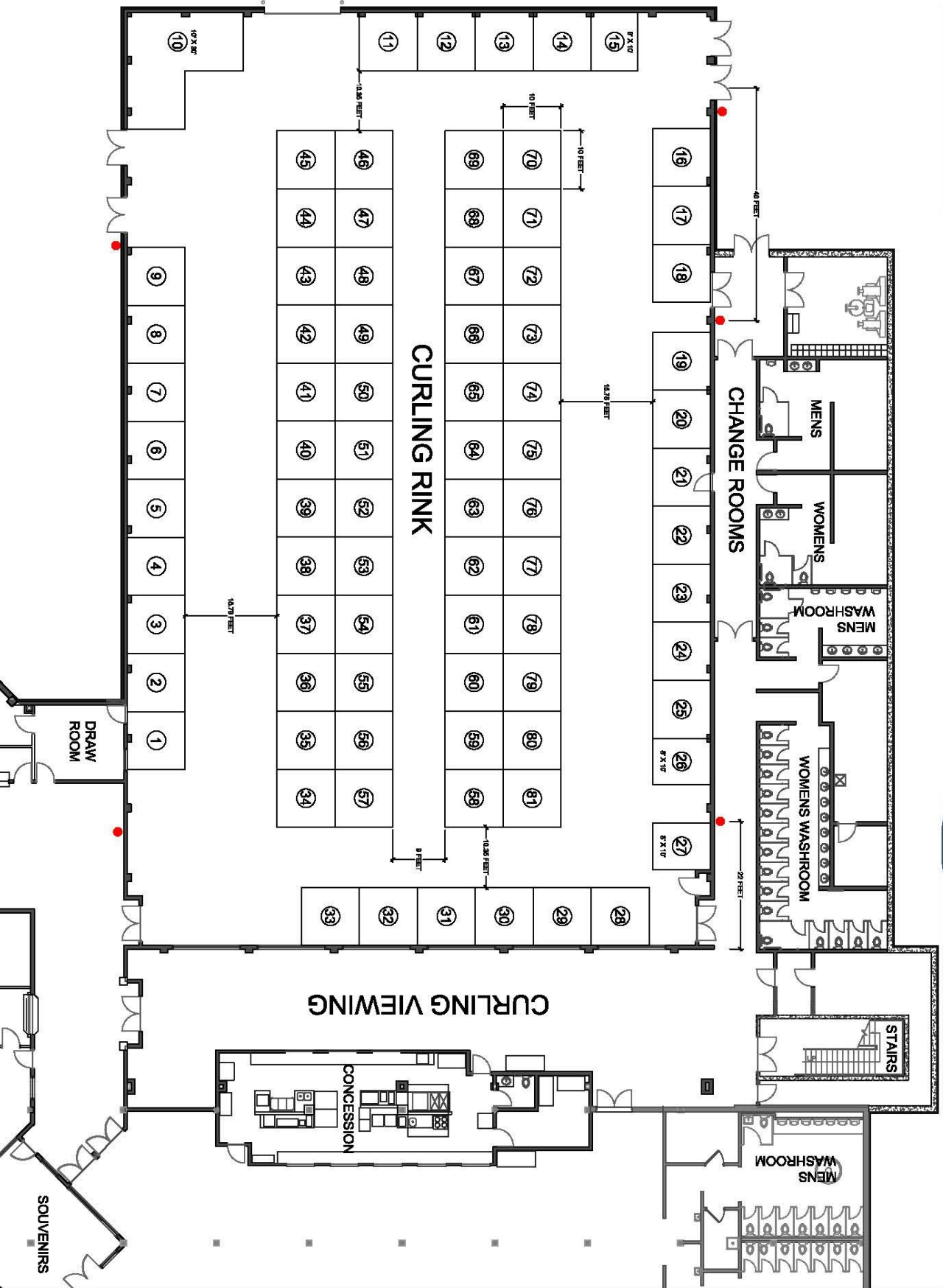
